**a.** <u>STDV-002601-2021</u> – Request from Hilton Head Island Fire Rescue, on behalf of Richette Mitchell and her family, to name a new access easement off Marshland Road as Oyster Man's Trace. *Presented by Fire Rescue Staff* 

Becky Neugent informed the Commission that the new access easement off Marshland Road will affect three addresses which are 94 Marshland Road, 60 Evelina Road, and 64 Evelina Road.

Deputy Chief Fister stated these were originally addressed off Evelina Road, but access must be granted over an existing access easement. Fire Rescue attempted to get agreements to gain access through Evelina Road and agreements could not be reached. She explained that created the need for a new access easement and road name. Deputy Chief Fister confirmed the access is being upgraded to the required width of 20 feet and an all-weather driving surface.

After discussion, Vice Chairman Perry moved to approve STDV-002601-2021. Commissioner Campbell seconded. By show of hands, the motion passed by a vote of 9-0-0.
