- Chairman Gant called the Circle to Circle Committee meeting to order at 8:37 a.m.
- The meeting agenda was approved.
- The meeting minutes from the March 25, 2015 meeting were approved.
- Chairman Gant introduced the first item of business: Circle to Circle Data. Maps summarizing the current land use and zoning districts were reviewed by the Committee.
- Chairman Gant then introduced the next agenda item, which included discussions of Sub-areas of the Circle to Circle to study area. Four sub-areas in the study area were identified by the Committee as the two areas around Coligny and Sea Pines Circles, the area along Palmetto Bay Road and Arrow Road west of the Sea Pines Circle and the Pope Avenue corridor.
- The Committee then discussed ideas related to community forums, background information with questions, format and schedule of community meetings and commercial/timeshare input.
- Chairman Gant suggested that he provide the Committee with a draft framework for the community forums to be discussed at the next meeting. The Committee would aim to hold a public meeting series at various locations in May to gain broad input from across the community, including residents and visitors.
- Following public comment, Chairman Gant adjourned the meeting at 10:35 a.m.
