1. Call to Order:

The meeting was called to order at 9:03 a.m.

4. Chairman's Report:

Brad Marra, Chairman, thanked all interested organizations present for attending the preliminary review of applications meeting. He stated that date for the 2019 Accommodations Tax Grant Awarding has been moved to the December 18th Town Council Meeting at 5:00 pm. Mr. Marra also stated that requests for the 2019 applications are approximately \$5.2M. The final amount available for awarding has not be determined as of yet, however, he indicated that funding will be approximately the same amount as last year, \$4.2M.
