# 3. Approval of Minutes:

Mr. Brown expressed his thoughts regarding a need for this area to grow and expand on the Gullah Culture. He believed that there is a need for community cultural organizations to collaborate on marketing efforts to increase the strong Gullah Community in this area. With the use of possible carry over funds, he stated that this could be used as an opportunity for cultural organization in the area to expand its strategic planning of cultural activities for tourists to enjoy. Overall, Mr. Brown thought that the applicants have continued to be good shepherds of the funding they received and to continue the good work in the 2018 cycle.

After the discussions of the individual applications, the Committee decided to carry over \$121,894 (plus the \$50,000 minimum reserve) for Town Council to award in the traditional grant cycle or possible out-of-cycle needs. The Committee felt that carrying funds over would help ensure a sustainable level of funding in the event that ATAX revenues should decrease for any reason.

Mr. Alsko made a motion to approve the recommendations as assigned and displayed on the projected spreadsheet (summarized in the table above) and to leave the remaining \$121,894 available to carry forward for the possible out-of-cycle needs. Mr. Bender seconded the motion. All Committee members voted unanimously to approve (except for individual line items where individual members recused themselves-details listed at end of minutes). (5-0 with the following exceptions: 4-0 Harbour Town Merchants Association, 4-0 Hilton Head Island – Bluffton Chamber of Commerce/VCB, 4-0 Hilton Head Wine and Food Festival, 4-0 Hilton Head Concours d'Elegance, 4-0 Lowcountry Golf Course Owners Association, 4-0 The Boys & Girls Club-Pedals Event, and 4-0 Shelter Cover Harbour Company).

During the discussion of the Harbour Town Merchants Association 4<sup>th</sup> of July Fireworks and Hilton Head Wine and Food Festival, Mr. Rob Bender disclosed a potential conflict of interest and did not participate.
