4. Unfinished Business

a. Review professional development survey results

Approximately 33% of surveys sent were completed. Overall positive results and interest in training organizations/ artists in business practices. Survey results will be reviewed in depth by four members of the committee and recommendations will be brought back to the full committee at the next meeting re: next steps.

b. Review definition of creative economy and proposed tactics and role of the committee

Proposal to merge the CAAC and ACCHH under the Office of Cultural Affairs was discussed. The new Arts Council of Hilton Head would include two arms. The first arm being the advocacy committee and populated initially by the current CAAC and they would continue work supporting the creative economy of Hilton Head Island. The other arm would be the Crescendo committee and would be populated from the current membership of the ACCHH and they would continue to produce Crescendo, the month long celebration of the arts on Hilton Head Island each October.

Dan Shapiro made a motion to move to approve the merger proposal of the CAAC with the ACCHH and present it to Community Services Committee pending the approval of the ACCHH. Tayloe Cook seconded the motion and the motion passed unanimously.
