- The meeting was called to order at 2:00 PM.
  - Taylor Ladd called the meeting to order and reviewed with the group a recap from the last meeting with a discussion that today's meeting is a continuation.
  - Ms. Ladd led the group through a discussion to revisit the goal statements. There was a minor changes suggested for the goal statements by the group:
    1. To be a continually driven people-focused community of excellence.
    2. To be a nationally recognized residential community of excellence that values and honors the history of the island and its people.
    3. For Hilton Head Island to be a Center for Excellence.
