- The meeting was called to order at 11:05 AM.
- Using the categories from the previous meeting, the group wrote the following draft goals:
 1. Establish a dedicated, Island-specific bus system (to include intermodal options) serving residents, workers, and tourists, linked with a regional transportation system.
 2. Enhance pathway connections on the Island, and establish a pathway connection between the Island and the mainland.
 3. "Right-size" the airport's capabilities and operations.
 4. Implement features that improve the efficiency of the road network.
 5. Ensure physical, social, and economic resilience from environmental challenges.
 6. Promote the efficient use of public utilities.
 7. Support resiliency of public utilities.
 8. Promote efficient public services (safety, emergency, planning, administration) to meet current and future needs.
 9. Promote housing options to meet the needs of all current and future demographics on the Island.
- The group will write a goal or goals for the Technology category at the next meeting, which will be September 27, 2019.
- Jack Mitchell with AT&T will make a presentation on 5G technology at the start of the next meeting.
