- Jayme Lopko displayed the previous themes and potential goal topics from the previous meeting. The Work Group discussed and drafted the following goals:
  1. Enable excellence in regional planning and coordination for the Town of Hilton Head Island as a built in part of the everyday process.
    - a. Increase communication and participation by Hilton Head Island and regional municipal, county, and state governments.
    - b. Build and strengthen existing relationships with regional economic development partners.
    - c. Increase advocacy efforts on legislative issues that affect our region.
  2. Increase supply of workforce/attainable housing on Hilton Head Island and in the regional within a reasonable commute.
    - a. Strategies to consider: incentives, housing trust fund
  3. Increase access between Hilton Head Island and the region through a viable multimodal transportation system.
    - a. Strategies to consider: public transportation, partnerships
  4. Strive to be the leader in the region for environmental protection and eco-friendly development practices.
    - a. Strategy to consider: landfill
  5. Expand regional tourism focus to promote diverse offerings across the Southern Lowcountry.
    - a. Strategies to consider: Beaufort County Heritage Tourism Corporation
