#### 1. Call to Order

Chairman Kisiah called the meeting to order at 3:30 p.m.

2. FOIA Compliance – Public notification of this meeting has been published, posted, and distributed in compliance with the South Carolina Freedom of Information Act and the requirements of the Town of Hilton Head Island.

#### 3. Swearing in Ceremony for Reappointed and new Commissioners

Mr. Josh Gruber, Assistant Town Manager performed the swearing in of reappointed Commissioner Kisiah and new Commissioners Mr. Joseph Monmonier and Mr. William Zurilla.

# 4. Presentation of the Town's Crystal Awards to outgoing Parks & Recreation Commissioners

Chairman Kisiah thanked Mike Ray and Caroline Rinehart for their service to the Parks & Recreation Commission.

#### 5. Approval of Minutes

Commissioner Okarma made a motion to approve the meeting minutes of March 12, 2020 as presented. Commissioner Daly seconded the motion. The motion passed unanimously.

#### 6. Citizen Comments

Public comments concerning agenda items were submitted electronically via the Town's Open Town Hall portal. The public comment period closed at Noon Wednesday, July 22<sup>nd</sup>. All comments were provided to the Parks & Recreation Commission members for review and made a part of the official record.

Citizens were provided the opportunity to sign up for public comment participation by phone during the meeting. There is one request from a citizens to speak on the agenda.

Mr. Skip Hoagland spoke on the topic of parks and recreational facilities and the cost it requires for repairs and maintenance. Mr. Hoagland questioned the use of tax dollars and the Chamber of Commerce funds.

#### 7. New Business

#### a. Election of Officers for the term of July 1, 2020 – June 30, 2021.

Commissioner Daly made a motion to elect Commissioner Kisiah to serve as Chairman for another term. Commissioner Okarma seconded the motion. The motion passed unanimously.

Commissioner Dowling made a motion to elect Commissioner Boes to serve as Vice Chairman for another term. Commissioner Okarma seconded the motion. The motion passed unanimously.

#### b. Discussion of the final version Parks & Recreation Master Plan Part 1

Ms. Ladd reported Lose Design, our Parks and Recreation consultant, delivered the final draft of this plan in June. What we are reviewing under this agenda item includes their budget, staffing, maintenance, needs assessment and gap analyses.

This document is intended to be informative, data-driven and a starting point for a larger process that entails planning and development for our parks and recreation system.

The Town's over-arching Parks and Recreation Master Plan is a multi-step process. If you notice the title for the Lose report says Parks and Recreation Master Plan Part 1. As Part 1, it lays the groundwork and provides research that is integral to taking the next steps towards progress for parks and recreation.

Part 2 is how this information is incorporated into section 4 of Our Plan, the Town's comprehensive plan, which the Parks & Recreation Task Group discussed earlier this month. The result of Part 2 is Action Items, goals and strategies for parks and recreation, based on the review of recommendations and public comments.

The parks and recreation section in Our Plan then lays the groundwork for part 3 of the process, which entails prioritization of projects, feasibility and funding analyses for projects and policy, and conceptual site planning. This is where we get into the details of how the recommendations will be implemented. This will also be incorporated into the Town's Capital Improvement Program process.

Finally Part 4 is the implementation process where we build the parks and initiate new policy.

Ms. Ladd stated the report we are discussing today is a guiding document at the very beginning of an exciting process.

Ms. Ladd thanked the Parks & Recreation Task Group, the Parks & Recreation Commission, community members and interest groups for their contribution to this effort and the time spent to help realize it and hopes they all will stay involved through the entire master planning process.

Chairman Kisiah complimented Town staff on doing a great job on this Plan.
