### RULES OF EVIDENCE AND PROCEDURE FOR BUSINESS LICENSE APPEAL HEARINGS HELD BEFORE THE TOWN COUNCIL OF THE TOWN OF HILTON HEAD ISLAND, SOUTH CAROLINA PURSUANT TO TOWN MUNICIPAL CODE SECTION 10-1-10 et seq.

### SECTION 1: PURPOSE AND INTENT.

It is the purpose of the Rules of Evidence and Procedure to establish an orderly, efficient and expeditious process for business license appeal hearings before the Town Council for the Town of Hilton Head Island, South Carolina (the "Town Council") pursuant to Town Municipal Code Section 10-1-10 *et seq*. The provisions of the Rules of Evidence and Procedure shall apply to such hearings held before the Town Council.

### **SECTION 2: GENERAL.**

(a) <u>Record</u>. A record of the entire proceedings shall be made by tape recording or by any other means of permanent recording determined to be appropriate by the Town Council.

(b) <u>Reporting</u>. The proceedings at the hearing may also be reported by a court reporter at the expense of the requesting party.

(c) <u>Continuances</u>. The Town Council may grant continuances for good cause.

(d) <u>Oaths and Affirmations</u>. The Town Council or any member thereof has the power to administer oaths and affirmations.

(e) <u>Reasonable Dispatch</u>. The Town Council and its representatives shall proceed with reasonable dispatch to conclude any matter before it. Due regard shall be shown for the convenience and necessity of any parties or their representatives.

### SECTION 3: FORM OF NOTICE OF HEARING.

The notice to parties shall be substantially in the following form, but may include other information:

"You are hereby notified that a hearing will be held before the Town Council of the Town of Hilton Head Island, South Carolina at Town Hall, One Town Center Court, Hilton Head Island, South Carolina 29928 on the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_, at the hour \_\_\_\_\_. You may be present at the hearing. You may be, but need not be, represented by counsel. You may present any relevant testimony and evidence and will be given full opportunity to cross-examine all witnesses testifying against you."

### SECTION 4: CONDUCT OF HEARING.

(a) <u>Rules</u>. Hearings need not be conducted in accordance with the South Carolina Rules of Civil Procedure, South Carolina Rules of Evidence, or any other federal, state, or local rules, other than the rules prescribed herein.

(b) <u>General Procedure</u>. The Mayor, or in his or her absence the Mayor Pro Tem, shall preside over the hearing and the receipt of all evidence. In the event of the Mayor and Mayor Pro Tem's absences, the Town Council may designate a member or members to preside over the hearing and the receipt of evidence. The order of procedure shall be as follows, which order can be modified only by the presiding member(s) and in the presiding member(s) sole discretion:

- (i) Appellant shall present its case
- (ii) Respondent shall present its case
- (iii) Appellant shall be allowed to rebut the Respondent's case

(c) <u>Oral Testimony or Evidence</u>. Oral testimony or evidence shall be taken only on oath or affirmation.

(d) <u>Hearsay Evidence</u>. Hearsay evidence may be used for the purpose of supplementing or explaining any direct evidence; however, such evidence standing alone shall not be sufficient to support a finding unless it would be admissible over objection in civil actions in courts of competent jurisdiction in South Carolina.

(e) <u>Admissibility of Evidence</u>. Any relevant evidence shall be admitted if it is the type of evidence on which reasonable persons are accustomed to rely upon in the conduct of serious affairs, regardless of the existence of any common law or statutory rule which might make improper the admission of such evidence over objection in civil actions in courts of competent jurisdiction in South Carolina.

(f) <u>Exclusion of Evidence</u>. Irrelevant and unduly repetitious evidence shall be excluded.

- (g) <u>Rights of Parties</u>. Each party shall have these rights, among others:
  - (i) To call and examine witnesses on any matter relevant to the issues of the hearing;
  - (ii) To introduce documentary and physical evidence;
  - (iii) To cross-examine opposing witnesses on any matter relevant to the issues of the hearing;

- (iv) To impeach any witness regardless of which party first called the witness to testify;
- (v) To rebut the evidence against the party; and
- (vi) To self-representation or to be represented by anyone of the party's choice who is lawfully permitted to do so.
- (h) <u>Official Notice</u>.
  - (i) <u>What may be Noticed</u>. In reaching a decision, official notice may be taken, either before or after submission of the case for decision, of any fact which may be judicially noticed by the courts of South Carolina or of official records of the Town or its departments and ordinances of the Town.
  - (ii) <u>Parties to be Notified</u>. Parties present at the hearing shall be informed of the matters to be noticed, and these matters shall be noted in the record, referred to therein, or appended thereto.
  - (iii) <u>Opportunity to Refute</u>. Parties present at the hearing shall be given a reasonable opportunity, on request, to refute the officially noticed matters by evidence or by written or oral presentation of authority, the manner of such refutation to be determined by the Town Council.

### SECTION 5: METHOD AND FORM OF DECISION.

(a) <u>Hearings</u>. In Hearings before the Town Council where a contested case is heard before the Town Council, no member thereof who did not hear the evidence or alternatively has not read or listened to the entire record of the proceedings shall vote on or take part in the decision. The presiding member(s) shall prepare findings of fact for the Town Council.

(b) <u>Form of Decision</u>. The decision shall be in writing and shall contain findings of fact and a determination of the issues presented. A copy of the decision shall be delivered to the parties personally or sent to them by certified mail, postage prepaid, return receipt requested.

(c) <u>Effective Date of the Decision</u>. The effective date of the decision shall be stated therein.

### Fun on Pope LLC Business License Application Timeline

**May 20, 2021**: Received notification from Code Enforcement that Ellie Bitton was observed setting up a new business for motor scooter rental at his business location of 77 Pope Ave

May 24, 2021: Received business license application from Fun on Pope LLC for motor scooter rentals

**May 25, 2021**: Requested Staff Attorney Diane Busch for a legal review of Fun on Pope LLC's business activity

**May 25, 2021**: Received notification from Deputy Town Manager Josh Gruber and Staff Attorney Diane Busch that the business license application will be denied for Fun on Pope LLC

June 1, 2021: Final draft of denial letter approved by Deputy Town Manager Josh Gruber

June 2, 2021: Denial letter sent certified mail to Fun on Pope LLC with the following reasons:

- 1) Town Code Sec. 12-1-511. Motor vehicles prohibited on pathways..." motor-assisted bicycles such as mopeds, motor scooters, golf carts, lawn mowers, all-terrain vehicles, go-carts, or any similar small motorized vehicles are prohibited on pathways."
- Town Code Sec.8-1-211. General beach prohibitions..." The driving or operating of any motor vehicle of any kind or nature on the beach is prohibited..."
- 3) SC Code 56-1-10(7) Motor scooters are defined as a motor vehicle.
- 4) SC Code 56-3-110 Motor vehicles are required to register with the Department of Motor Vehicles, maintain motor vehicle insurance and the operator of the motor vehicle must hold a valid driver's license.

**June 7, 2021**: Business License staff notified me that Ellie Bitton inquired about rentals of paddle boards and hover boards. I followed up with Staff Attorney Diane Busch and Deputy Town Manager Josh Gruber with his request. The request for hover board rentals would not be allowed for the same reasons as the motor scooters. Notified Ellie Bitton via email.

**June 14, 2021:** Notified by Town Clerk Krista Wiedmeyer that the Town received a request to appeal the denial of Fun on Pope LLC's business license application

**June 17, 2021**: Received notification from Code Enforcement that Fun on Pope LLC leased motor scooters through a rideshare rental platform called Sunday Scooters. Both Fun on Pope LLC and Sunday Scooters will require a business license to operate.





I regret to inform you the license department has declined to grant your business license application for "motor scooter rentals" for Fun on Pope LLC for the following reasons:

- 1) Town Code Sec. 12-1-511. Motor vehicles prohibited on pathways..." motor-assisted bicycles such as mopeds, motor scooters, golf carts, lawn mowers, all-terrain vehicles, go-carts, or any similar small motorized vehicles are prohibited on pathways."
- 2) Town Code Sec.8-1-211. General beach prohibitions..." The driving or operating of any motor vehicle of any kind or nature on the beach is prohibited..."
- 3) SC Code 56-1-10(7) Motor scooters are defined as a motor vehicle.
- SC Code 56-3-110 Motor vehicles are required to register with the Department of Motor Vehicles, maintain motor vehicle insurance and the operator of the motor vehicle must hold a valid driver's license.

The Municipal Code of the Town of Hilton Head Island, Section 10-1-140, mandates that a business license official shall deny a license when, "...the applicant does not comply with all other applicable town ordinances...".

You do have the right to appeal this denial pursuant to the Town of Hilton Head Island Municipal Code directly to the Town Council. Section 10-1-160 sets forth the procedures, yet please note your appeal must be delivered, in writing, within ten (10) days to the town clerk.

Please be advised that our firm represents Mr. Ellie Bitton and Fun on Pope, LLC. By this letter, we are appealing the denial of a business license for his company which plans to rent electric scooters.

First, I believe your interpretation of State law is incorrect. S.C. Code 56-1-10 (7) is not the controlling definition. Arguably, S.C. Code 56-1-10 (8) definition of "motorcycle" would be closer. Under South Carolina law, there is no scooter classification, only motorcycle, and moped. The size of the engine determines the classification. If the engine is 50 ccs or less, it is considered a moped. Anything greater than 50 ccs is a motorcycle.

Attached you will see from the manufacturer's brochure, which states that the motor speed of these scooters can be either 250,350, or 400 watts. 50 ccs are the equivalent to approximately 2500 watts. So, 250 watts is approximately 5 ccs. As a motorized vehicle under 50 ccs, the scooter needs to be registered with the DMV. It does not have to carry insurance, and any operator must have a Class G, D, or M license.

The problem with 12-1-511 (2) is the inconsistency with which it is applied. For instance, under that code section, electric bicycles are also prohibited. However, Hilton Head E-bikes (115 Arrow Rd, HHI, SC 29928) is presumably licensed by the Town to rent ebikes in contradiction to Town Code 12-1-511 (2). Presumably, Avocado Bike Electric Rentals (890 William Hilton Pkwy. | Hilton Head Island, SC 29928) also holds a business license to rent electric bikes in contravention of TC 12-1-511 (2). Presumably, the same applies to Hilton Head Bicycle Company, Island Life Bike Rentals, and Atlantic bikes, to name a few more.

For that matter, while I understand that the law states that Segways, since their wheels are not in tandem, do not fall into this classification, I believe that using that as a justification is disingenuous at best and falls short of the spirit of the law. Segways travel at 750 watts, are three times as fast, and are much more difficult to operate, making them a far greater hazard than scooters or electric bikes. Again, please accept this letter as our official request to Appeal the Town's June 2, 2021 decision, denying Mr. Bitton's business license.
