The Notice of Violation was issued pursuant to section 114.1 (Unlawful Acts) of the International Building Code (IBC).

Mr. Patrick J.T. Kelley, P.C. presented the appeal on behalf of Mr. Ramos. Mr. Kelley reported on the history of this property, the structure in question and the need for Mr. Ramos to remain on this property due to financial constraints.

Mr. Yates began his presentation by reading the timeline of events performed by Town Staff at this property.

After much discussion regarding flood elevation, electric meters and the building code the Chairman asked for a motion.

Mr. Nix made a motion the Board have further discussion on this appeal. Mr. Ellis seconded the motion. The motion passed unanimously.

Mr. Zinn made a motion that the Construction Board of Adjustments and Appeal concur with the Building Official's determination that the Illegal Non-Conforming structure located at 7 Sam Frazier Retreat, Hilton Head Island is an unpermitted structure that is being unlawfully used for habitation in violation of the Code.
