Welcoming Remarks:

Introduction:

Shawn Colin, Deputy Director of Community Development, thanked everyone for attending and provided a brief history of events leading up to this point. The main purpose of today's workshop is for the members of Town Council in attendance to ask meaningful questions of the Panelists as the Town moves forward to program for Hilton Head Island.

Jennifer Ray, Planning & Special Projects Manager, introduced the Panelists.

Presentations by Panelists:

A presentation was made by each jurisdiction outlining a brief history, current programming and organizational structure, and comments on lessons learned that could benefit Hilton Head Island. The Panelists provided information on their respective municipality's role in the process, how the project was funded, and resourceful partnerships.

Town Staff and Town Council members made inquiries specific to each community.

General Discussion and Questions from Town Council to Panelists:

The discussion and questions from Town Council members and Town Staff to the Panelists pertained to: means to provide housing opportunities for certain low income levels with multiple family members; providing financial support through certain terms and conditions in the development agreement; balancing affordable housing and cost of living; providing and maintaining infrastructure, roads and sidewalks; funding; affordable housing tax credits; and enabling legislation to create a balance of the toolkit.

Public Comments:

The public comments received related to: tools to handle or improve Nimbyism; and incentives for existing homeowners to provide affordable housing.

Closing Remarks:

Mayor Bennett thanked the Panelists and Town staff for their participation and efforts.
